Announcement of Zhejiang Huayou Cobalt Co., Ltd. on Amending the Articles of Association

The Board of Directors and all directors of the Company warrant that there is no false representation, misleading statement or material omissions herein, and will assume joint and several liabilities with respect to the truthfulness, accuracy and completeness hereof.

Zhejiang Huayou Cobalt Co., Ltd. (“Huayou Cobalt” or the “Company”) held the 21st meeting of the 6th Board of Directors on September 20, 2024, in which the *Proposal on Amending the Articles of Association* was deliberated and approved. Relevant information is hereby announced as follows:

I. Amending the Articles of Association

Based on its business development needs, the Company plans to amend the Articles of Association as follows:

The above amendment still needs to be submitted to the shareholders' meeting for deliberation. According to the opinions and requirements of the industrial and commercial registration authority, this amendment to the Articles of Association, after being consolidated with the *Proposal on Changing Registered Capital and Amending the Articles of Association*, will be submitted to the shareholders' meeting for deliberation and subject to the approval of more than two-thirds of the voting rights held by shareholders present thereat.

Except for the said provision, other contents of the *Articles of Association* remain unchanged. The full text of the amended Articles of Association was published on the website of the Shanghai Stock Exchange (www.sse.com.cn) on the same day.

II. Procedures for registration of change

Now it is submitted to the shareholders' meeting seeking that the shareholders' meeting will authorize the board of directors and relevant personnel to complete the procedures for industrial and commercial registration of change, filing of Articles of Association, and other related matters after the approval of the shareholders' meeting. The content of the said changes is subject to that finally approved by the industrial and commercial registration authority. The Company will promptly apply to the industrial and commercial registration authority to complete relevant procedures after the approval of the shareholders' meeting.
